Data Protection Privacy Notice for Governors and Other Volunteers

This document describes the information we collect about our governors and volunteers, and how we use and share this information.

Under data protection legislation Coulsdon C of E Primary School is the data controller of the personal information we hold. The school designates the Head Teacher as its representative with regards to data protection.

Why do we collect and use your information?

Coulsdon C of E Primary School is a non-profit charitable school funded by the Department for Education (DfE). It is required that personal data is collected & processed in order to enable the effective and safe running of the school. We process personal data in order to meet the legal obligations & safeguarding requirements set out in UK employment and childcare law.

The information we hold may include names, addresses and contact details. It may also include sensitive personal characteristics such as your ethnic group and we keep photographs of governors and volunteers for safeguarding and identification reasons.

The information we hold is data that has either been provided to us by you, or gather during the course of your Governorship or Volunteering. The school is obliged to record this information in order to carry out its duties as a public body.

The school may identify additional uses of your data, which may be of benefit to the school community. Examples may include optional extra-curricular activities, fundraising or promotional activities. We will always seek your consent before using your data for these reasons. If you give consent, you may change your mind at any time.

How long is your data stored for?

Personal data relating to the school governors and volunteers is stored in line with the school's Data Retention Policy. We keep information for as long as the law requires us to do so, and it is deleted when it is no longer required. You can see further details in the policy on our school website or upon request to the school office.

Will my information be shared?

We do not share information about our governors or volunteers with external agencies without prior consent, or unless the law or our policies require us to do so.

We are required to share some personal information with Local Authorities, the DfE and our Auditors.

The information shared may include sensitive personal information and is shared on a strictly need to know basis.

We may also share data with approved third parties or contractors in order to support governor's or volunteer's training & development, health and wellbeing. Examples may include training providers or service suppliers (such as catering, payment processing services and communication tools).

Requesting access to your personal data

Under data protection legislation, staff have the right to request access to view the information that we hold about them. Requests for access to your personal information must be recorded in writing. You may make a request verbally by speaking to a member of staff who will record your request.
